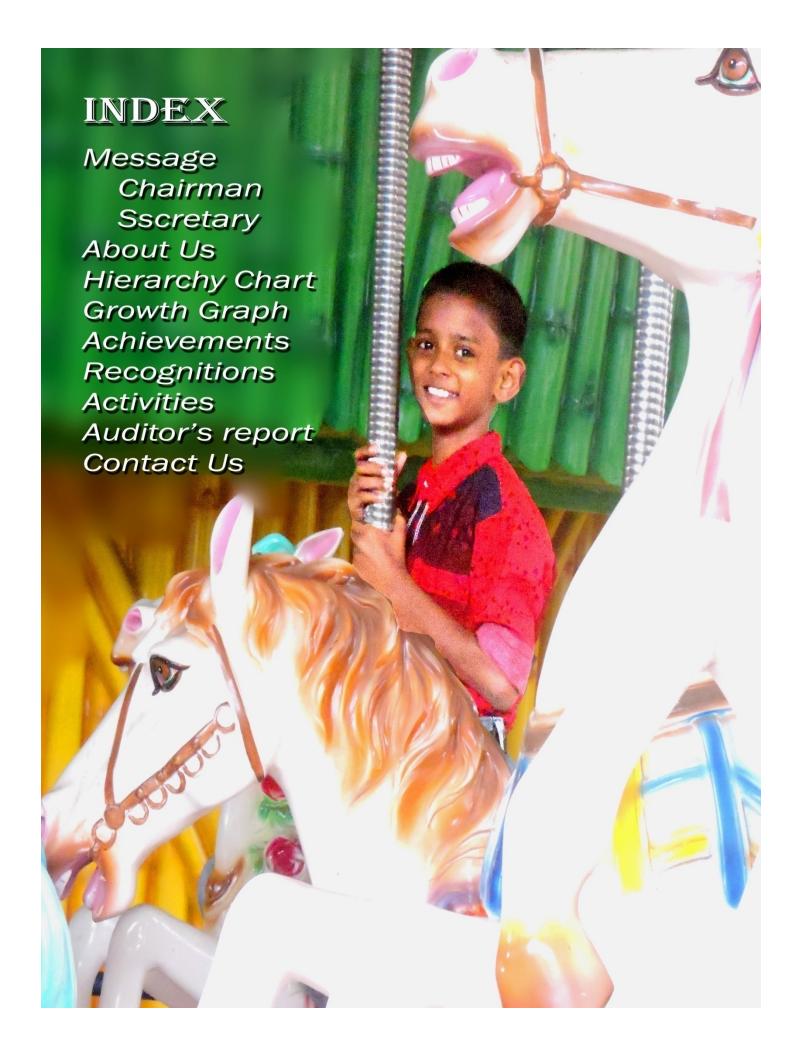

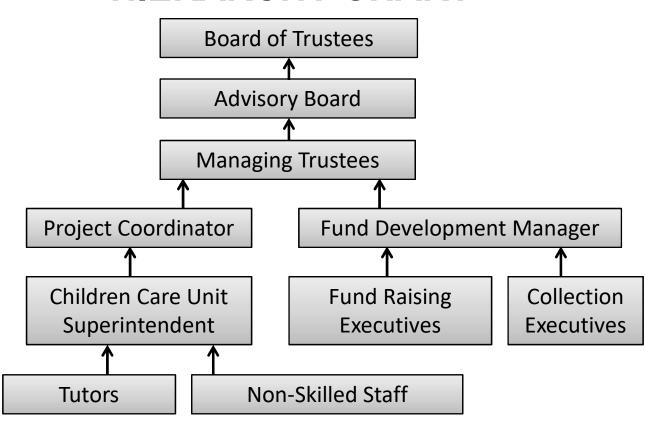
ABOUT US

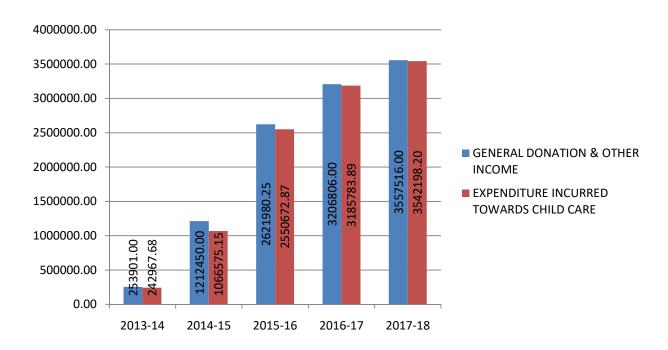

HIERARCHY CHART



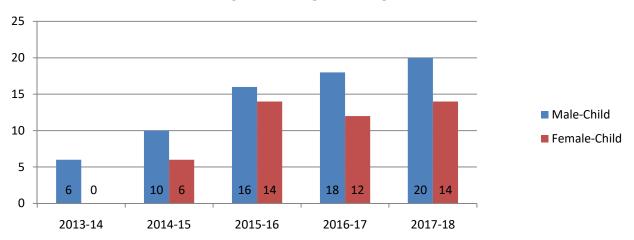
Our growth graph from the day we began our activities.

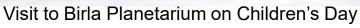

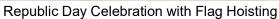

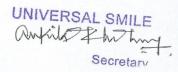
